



M/s. Mitesh Mehta & Associates, Chartered Accountants, (Registration number: 106447W), the Auditors of the Company have resigned as statutory auditors of the Company with effect from 14th December, 2023, due to personal reasons thereby resulting in a casual vacancy in the office of Auditors.
