

Dear Shareholders,

As per the provisions of the Companies Act, 2013, the Company had provided the facility of remote e-voting and voting through ballot paper at the meeting to the Shareholders to enable them to cast their vote on the resolutions proposed in the Notice of the NCLT Convened Meeting of the Equity Shareholders of the Company. The e-voting was open from 17th November, 2020 (9.00 A.M) to 19th September, 2020 (5.00 P.M).

In line with the provisions of the Companies Act, 2013 and in terms of the clarification issued by MCA, voting by Show of Hands was not permitted at the Meeting where e-voting has been offered to the Shareholders. Therefore, voting was conducted by means of remote e-voting and ballot at this Meeting
