Sub.: Scrutinizer's Report on Postal Ballot by Physical Ballots and remote e-voting conducted pursuant to the provisions of section 110 of the Companies Act, 2013, read with Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time.

I, Jay Dilipkumar Mehta, proprietor of M/s Jay Mehta & Associates, Company Secretaries, appointed as Scrutinizer, by the Board of Directors of **All Indian Origin Chemists & Distributors Limited** (the Company), for the purpose of scrutinizing the postal ballot by physical ballots and remote e-voting as per the provisions of section 110 of the Companies Act, 2013 read with Rule 22 of the Companies (Management and Administration) Rules, 2014, as amended from time to time.
